

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1360EM17T, 21-Month Term Contract for the Comprehensive Maintenance and Repair of Lift Installations at Various Premises of Hospital Authority (OT 17)**. The scope of Works includes the maintenance and repair of lift installations in various premises of the Hospital Authority. The Contract Period is 21 months and the Contract is scheduled to commence in September 2017.
