SCHEDULE

Foreshore and sea-bed affected

Approximately 12.08 hectares of foreshore and sea-bed situated at Starling Inlet (Sha Tau Kok Hoi) as delineated and shown edged red on a plan, numbered DNM3266, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

The proposed works include:—

- (i) Modification of the existing submarine outfall and diffuser;
- (ii) Construction of a new submarine outfall of about 1 700 metres in length from the shore by horizontal directional drilling at a depth of up to 90 metres below the sea-bed. Dredging of sea-bed is not required, except at the end section of the outfall; and
- (iii) Erection of a temporary works area at the end section of the new submarine outfall to facilitate excavation and construction of the diffuser.

Personal Information Collection Statement
