**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF PART OF WAN CHAI SPORTS GROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 May 2017 (the ‘Order’), authorized the temporary closure of part of Wan Chai Sports Ground, as delineated and shown in yellow on the Plan numbered SCL/G35/0038/3 during the period from 3 June 2017 to 2 June 2018 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of Wan Chai Sports Ground to be affected and the manner in which it will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G35/0038/3 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near Wan Chai Sports Ground affected by the Order on 19 May 2017.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Wan Chai Sports Ground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Wan Chai Sports Ground affected by the Order.

Notice is hereby given that further closure of the same part or parts of Wan Chai Sports Ground or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

Part of Wan Chai Sports Ground, as delineated and shown in yellow on the Plan numbered SCL/G35/0038/3.	Part of Wan Chai Sports Ground will be temporarily closed to facilitate the construction of the railway tunnel, the railway station and the associated railway facilities of the Shatin to Central Link.
