

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PROPOSED TRAFFIC IMPROVEMENT MEASURES  
TO FUI YIU KOK STREET AND TSUEN YIP STREET

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. HNHADMINS-GZ0024 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) widening the carriageway of Fui Yiu Kok Street from approximately 7.3 metres to approximately 10.3 metres for providing loading/unloading bays;
- (ii) conversion of sections of the existing emergency vehicular access into carriageway and footpaths at Tsuen Yip Street by erection of steel bollards on both sides of Tsuen Yip Street to delineate a 6.0 metres wide carriageway with approximately 1.4 metres and approximately 1.6 metres wide footpaths respectively on both sides;
- (iii) permanent closure and conversion of sections of the existing carriageway into footpath at Fui Yiu Kok Street;
- (iv) permanent closure and conversion of sections of the existing footpaths into carriageways at Fui Yiu Kok Street, Lung Tak Street and Ma Kok Street;
- (v) permanent closure and conversion of a section of the existing emergency vehicular access into carriageway at Tsuen Yip Street;
- (vi) permanent closure and conversion of sections of the existing emergency vehicular access into footpaths at Tsuen Yip Street;
- (vii) temporary closure of sections of the existing carriageways, footpaths and emergency vehicular access; and
- (viii) ancillary works including drainage, utilities and public lighting works.

The Plan and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person who wishes to object to the works or the use, or both, is required to address his objection in writing to the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the office of the Secretary not later than the 18th day of July 2017, describing his interest and the manner in which he alleges that he will be affected by the works or the use. Objectors are requested to provide contact details to the Secretary to facilitate communication.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
