PROPOSED ROAD WORKS AT KO CHIU ROAD, YAU TONG, KOWLOON

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. KM9628 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:-

- (i) construction of a single two-lane carriageway with footpaths, run-ins/run-outs and pedestrian crossings;
- (ii) permanent closure and conversion of a section of the existing footpath along Ko Chiu Road into carriageway;
- (iii) permanent closure of a section of the existing footpath connecting to Wilson Trail;
- (iv) permanent closure and conversion of an existing run-in/run-out into carriageway and footpath;
- (v) demolition and conversion of sections of the existing slopes into carriageway, footpath near Ko Chiu Road and footpath connecting to Wilson Trail;
- (vi) temporary closure and reconstruction of sections of the existing footpath;
- (vii) temporary closure of sections of the existing carriageways and footpaths; and
- (viii) ancillary works including landscaping, water, drainage, sewerage, utilities, lighting, slope and reinstatement works.
