# ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370) (Notice under section 8(2))

## DEVELOPMENT OF LOK MA CHAU LOOP: LAND DECONTAMINATION AND ADVANCE ENGINEERING WORKS (ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 184794/LMC/GZ/001 to 184794/LMC/ GZ/006 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:----

- (i) construction of sections of an at grade carriageway for one-lane two-way traffic and at grade footpaths at Ha Wan Tsuen East Road;
- (ii) construction of a temporary elevated carriageway and a temporary elevated footpath spanning across the meander between Ha Wan Tsuen East Road and Lok Ma Chau Loop as a construction access which will be demolished after completion of the permanent access to the Lok Ma Chau Loop;
- (iii) construction of pedestrian crossings at Ha Wan Tsuen East Road;
- (iv) construction of temporary vertical noise barriers alongside sections of Lok Ma Chau Road which will be demolished after completion of the permanent access to the Lok Ma Chau Loop;
- (v) permanent closure and conversion of sections of the existing at grade carriageway at Ha Wan Tsuen East Road into at grade footpaths;
- (vi) permanent closure and demolition of sections of the existing at grade carriageway at Ha Wan Tsuen East Road;
- (vii) permanent closure and conversion of a section of the existing at grade footpath/track at Ha Wan Tsuen East Road into an at grade carriageway for one-lane two-way traffic;
- (viii) temporary closure and reconstruction of sections of the existing at grade carriageway at Ha Wan Tsuen East Road, of which a section will be converted from one-lane one-way traffic into one-lane two-way traffic;
- (ix) temporary closure and reconstruction of a section of the existing at grade footpath/track at Ha Wan Tsuen East Road;
- (x) temporary closure of sections of the existing at grade carriageways and at grade footpaths/ tracks; and
- (xi) ancillary works including street lighting, geotechnical, drainage and utilities works and construction of retaining walls.
