

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PROPOSED ROAD WORKS AT LUNG CHEUNG ROAD,
KOWLOON TONG, KOWLOON

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. KM9719 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a footbridge with lifts and staircases spanning across Lung Cheung Road and the slip road connecting Lung Cheung Road westbound to Lion Rock Tunnel Road northbound;
- (ii) construction of carriageways, footpaths, a refuge island, a bus stop and a bus lay-by;
- (iii) modification and realignment of sections of Lung Cheung Road;
- (iv) modification and realignment of a section of the existing staircase connecting Lung Cheung Road westbound and Waterloo Road;
- (v) widening and modification of a section of the existing access road connecting Lung Cheung Road and Lion Rock High Level No. 2 Primary Service Reservoir;
- (vi) permanent closure and conversion of sections of the existing carriageways into footpaths, central reserves and refuge island;
- (vii) permanent closure and conversion of sections of the existing footpaths into carriageways, central reserve, refuge island and verge;
- (viii) permanent closure and conversion of a section of existing staircase into carriageway and footpath;
- (ix) permanent closure and conversion of sections of the existing amenity areas into carriageway, footpath and staircases;
- (x) permanent closure and conversion of a section of the existing central reserve into carriageway;
- (xi) demolition and conversion of sections of the existing slopes into carriageways, footpaths, staircases, refuge island and lifts;
- (xii) temporary closure and reconstruction of sections of the existing carriageways, footpaths, staircase and central reserve;
- (xiii) temporary closure of sections of the existing carriageways, footpaths, staircase, amenity areas and central reserve; and
- (xiv) ancillary works including construction of retaining walls and slopes, as well as geotechnical, drainage, sewerage, water, utilities, street lighting and landscaping works.

Objectors are requested to provide contact details to the Secretary to facilitate communication.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
