

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1557EM16W—Supply and Installation of Gantry Type X-ray Vehicle Inspection Systems at Liantang/Heung Yuen Wai Boundary Control Point**. The scope of the works includes the design, supply, delivery, installation, testing and commissioning (construction works), and the subsequent 9-year maintenance services (maintenance services) of the Gantry Type X-ray Vehicle Inspection Systems at the Liantang/Heung Yuen Wai Boundary Control Point. Construction works is scheduled to commence in October 2017 for completion in October 2018. Maintenance services is scheduled to commence in November 2019 for completion in November 2028.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box located at the lift lobby on the Ground Floor of North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 28 July 2017. Late tenders will not be accepted.
