

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1025EM171—Triennial Term Contract for Provision of Maintenance, Modification and Installation Works of Electronic and E&M Control Systems at Various Sewage Treatment Works and Their Outstations.** The scope of the works includes maintenance, repair, alteration and additional services of electronic and E&M control systems at various sewage treatment works and their outstations across Kowloon, New Territories and the Outlying Islands. The contract period is 36 months and the Contract is scheduled to commence in December 2017 for completion in November 2020.
