MARINE PARKS ORDINANCE (Chapter 476)

(Section 8(1))

In accordance with section 7 of the Marine Parks Ordinance (Chapter 476) ('the Ordinance'), the Country and Marine Parks Authority has prepared a draft map (Plan No. MP/SWL) for the proposed Southwest Lantau Marine Park ('the Proposed Marine Park').

The Proposed Marine Park is located in the southwestern waters of Lantau and covers two sea areas of about 650 hectares. The seaward boundary of the Proposed Marine Park is shown in the draft map. The landward boundary will be demarcated with reference to the high water mark along the coastline of Peaked Hill and the Southwest Lantau.

Copies of the draft map, together with other information relating to the Proposed Marine Park, are available for inspection by the public free of charge at the following Government Offices for a period of sixty days from the date of publication of this notice during the following hours when these offices are normally open to the public:—

Such written statement shall set out:—

- (a) the nature of and reasons for the objection; and
- (b) if the objection would be removed by an alteration to the draft map, any alteration proposed.
