

It is hereby notified that sealed tender in triplicate is invited for the **Supply of Turf, Topsoil and Subsoil for Hong Kong, Kowloon and New Territories Districts of the Leisure and Cultural Services Department for a period of 24 months from 16 November 2017 to 15 November 2019 (Tender Ref.: LCT 8003/17(G))**.
