**Public Health and Municipal Services Ordinance (Public
Pleasure Grounds) (Amendment of Fourth Schedule)
Order 2017**

(Made by the Director of Leisure and Cultural Services under section
106 of the Public Health and Municipal Services Ordinance
(Cap. 132))

1. Places set aside for use as public pleasure grounds

Explanatory Note

This Order sets aside 10 places for use as public pleasure grounds and provides that 1 place ceases to be set aside for use as a public pleasure ground.

2. The Order also amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to—
 - (a) add the 10 places and remove the 1 place mentioned in paragraph 1; and
 - (b) reflect that—
 - (i) “Hang Fa Chuen Playground” has been renamed, in English only, as “Heng Fa Chuen Playground” for “杏花邨遊樂場”; and
 - (ii) “Cape Collinson Road Sitting-out Area” has been renamed, in Chinese only, from “哥連臣角道休憩處” to “歌連臣角道休憩處”.
