

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1850EM16W—Replacement of Tunnel Lighting System in the Kai Tak Tunnel**. The scope of the works includes the replacement of the whole tunnel lighting system in the Kai Tak Tunnel.
