

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1660EM17T—Triennial Term Contract for Operation and Maintenance of Data Centre Infrastructure at Siu Ho Wan Maintenance Depot**. The scope of works includes the routine preventive maintenance, system operation and monitoring as well as fault call attendance on electrical, air-conditioning and uninterruptible power supply systems of Data Centre at Siu Ho Wan Maintenance Depot. The contract period is 36 months and the Contract is scheduled to commence in October 2017 for completion in September 2020.
