

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. NE/2017/01 Tseung Kwan O—Lam Tin Tunnel—Tseung Kwan O Interchange and Associated Works. The works include construction of marine viaducts forming the Tseung Kwan O Interchange.** The works are scheduled to commence in end 2017 and will take about 38 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 1 September 2017. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 1 September 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Roads and Drainage Category who also meet the following qualification and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one construction contract involving roads and drainage works with an awarded contract value of not less than HK\$300 million, in or outside Hong Kong, within the past 15 years counting from the original date set for the close of tender; and
- (ii) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one construction contract involving precast segmental construction method concrete bridge works with a total bridge deck surface area between inner sides of edge parapets not less than 5 000 square metres, in or outside Hong Kong, within the past 15 years counting from the original date set for the close of tender.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 7 August 2017 to Chief Engineer/NTE1, New Territories East Development Office, Civil Engineering and Development Department at 12th Floor, Suite 1213, Chinachem Golden Plaza, 77 Mody Road, Tsim Sha Tsui East, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
