

It is hereby notified that sealed tender in triplicate is invited for the **Provision of Cleansing and Supporting Services to Hong Kong Coliseum and Queen Elizabeth Stadium of the Leisure and Cultural Services Department for a period of 36 months from 1 January 2018 to 31 December 2020 (Tender Ref.: LCT 5002/17(S)).**
