

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2605EM16T—Triennial Term Contract for Operation and Maintenance of Air-conditioning Installations for Hong Kong Police Force and Independent Commission Against Corruption for the Government of HKSAR**. The scope of the works includes provision of operation and maintenance services, and carrying out of alteration, addition, replacement and improvement works of air-conditioning installations for venues of the Hong Kong Police Force and Independent Commission Against Corruption. The works are scheduled to commence in October 2017 for completion in September 2020.
