## PWP ITEM NO. 6178TB— LIFT AND PEDESTRIAN WALKWAY SYSTEM BETWEEN CASTLE PEAK ROAD AND KUNG YIP STREET, KWAI CHUNG

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Acting Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. HWDKS165A-GZ0001 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:----

- (i) construction of a lift tower with two lifts of approximately 40 metres (m) in height adjacent to Kung Yip Street;
- (ii) construction of a lift tower with one lift of approximately 10 m in height adjacent to the western footpath of Castle Peak Road—Kwai Chung;
- (iii) construction of a lift tower with two lifts of approximately 40 m in height adjacent to the eastern footpath of Castle Peak Road—Kwai Chung;
- (iv) construction of an elevated pedestrian walkway of approximately 3 m in clear width and 75m in length to connect the lift towers in (i), (ii) and (iii);
- (v) construction of an elevated pedestrian walkway of approximately 3 m in clear width and 50m in length to connect the lift tower in (iii) and Shek Lei (I) Estate;
- (vi) construction of staircases to connect the elevated pedestrian walkway in (iv) with the eastern and western footpaths of Castle Peak Road—Kwai Chung;
- (vii) construction of sections of footpaths adjacent to the lift towers in (i), (ii) and (iii) and in Shek Lei (I) Estate;
- (viii) permanent closure and conversion of sections of the existing carriageways at Castle Peak Road—Kwai Chung, Shek Pai Street and Kung Yip Street into footpaths;
- (ix) temporary closure and reconstruction of sections of the existing footpaths at Castle Peak Road—Kwai Chung, Shek Pai Street and Kung Yip Street;
- (x) temporary closure and reconstruction of the existing amenity area at Castle Peak Road— Kwai Chung;
- (xi) temporary closure of sections of the existing carriageways, footpaths, amenity areas, central dividers/refuge islands and pedestrian crossings; and
- (xii) ancillary works including geotechnical, drainage, landscaping, electrical and mechanical, public lighting and utility works.
