TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central medians/traffic islands and pedestrian crossings within the limit of works area as shown on Plan No. KZ850 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 187 published on 15 January 2016 and 22 January 2016. The Acting Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 9 September 2017 to 8 September 2018, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central medians/traffic islands and pedestrian crossings to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a covered four-span footbridge with associated lifts and lift towers, covered staircases, covered escalators, footbridge abutments, footbridge columns and footpath at the junction of Sham Mong Road/Tonkin Street West.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.
