

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1393EM16T—Triennial Term Contract for the Comprehensive Maintenance and Repair of Escalator Installations at Various Premises of the Government of the Hong Kong Special Administrative Region (Package One of HT16E)**. The scope of the works includes comprehensive maintenance and repair of escalator installations at various premises of the Government of the Hong Kong Special Administrative Region. The works are scheduled to commence in January 2018 for completion in December 2020.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Government Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 20 October 2017. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 20 October 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered.

Open tendering is adopted. Contractors who meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (A) Contractor must be a registered escalator contractor under the Lifts and Escalators Ordinance (Chapter 618 of the Laws of Hong Kong); and
- (B) Contractor must have completed escalator maintenance contracts in or outside Hong Kong within the past 5 years with the minimum accumulated awarded contract sum of not less than HK\$5 million.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender with the highest overall score.
