

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1039EM17T—Five-year Term Contract for Maintenance, Modification and Installation Works of Area Traffic Control System in Hong Kong Island.**

The scope of the works includes comprehensive maintenance, modification and installation works for the Hong Kong Area Traffic Control (HKATC) System, as well as provision of first line maintenance for traffic signals and accessories equipment. The Contract is scheduled to commence in January 2018 for completion in January 2023.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to 'The Chairman, Public Works Tender Board' and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon, Friday, 24 November 2017. Late tenders will not be accepted.

In the case of a joint venture, only the lead participant or major shareholder is required to meet this experience requirement.
