

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)  
(Notice under section 18)

PWP ITEM NO. 7754CL (PART)  
INFRASTRUCTURE WORKS FOR WEST KOWLOON  
CULTURAL DISTRICT, PHASE 1 (PART)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths, part of an existing central median/traffic island, as well as the existing pedestrian crossings, within the limit of works area as shown on Plans Nos. KZ825, KZ826 and KZ827 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 1632 published on 13 February 2015 and 18 February 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 30 October 2017 to 29 October 2018, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths, part of an existing central median/traffic island, as well as the existing pedestrian crossings to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a carriageway with associated footpaths, central medians/traffic islands and vehicular run-ins, two lay-bys and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, central median/traffic island and pedestrian crossings on 20 October 2017.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—

- (1) By post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8.00 a.m. and 7.00 p.m. from Monday to Friday (except public holidays);
