

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. NE/2017/03, Development of Anderson Road Quarry Site—Road Improvement Works and Pedestrian Connectivity Facilities Works Phase 2A**. The works mainly comprise:—

- (a) road improvement works at junction of Clear Water Bay Road and On Sau Road; New Clear Water Bay Road near Shun Lee Tsuen Water;
- (b) construction of a vehicular flyover from Lin Tak Road to Sau Mau Ping Road and provision of laybys at Lin Tak Road;
- (c) construction of pedestrian connectivity facilities, including footbridge, lift towers and escalators in Kwun Tong district;
- (d) provision of public toilet for the proposed bus-bus interchange at Tseung Kwan O Tunnel Toll Plaza; and
- (e) associated noise enclosures and barriers, slope works and landscaping works.

The works are scheduled to commence in early 2018 and will take about 58 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box located on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 15 December 2017. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 15 December 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the participant/shareholder collectively in case of a joint venture tenderer, has completed at least one construction contract involving roads and drainage works with an awarded contract value of not less than HK\$800 million, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender; and
- (ii) The tenderer, or the participant/shareholder collectively in case of a joint venture tenderer, has completed at least one construction contract involving vehicular bridge works with a total bridge deck surface area between inner sides of edge parapets not less than 600 square metres, in or outside Hong Kong, within the past 10 years counting from the original date set for the close of tender.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (Confirmed) under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 15 November 2017 to Chief Engineer/NTE2, New Territories East Development Office, Civil Engineering and Development Department at 12th Floor, Suite 1213, Chinachem Golden Plaza, 77 Mody Road, Tsim Sha Tsui East, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
