

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 05/HY/2017—Highways Department Term Contract (Management and Maintenance of Roads in Kowloon East excluding Expressways and High Speed Roads 2018–2024)**. This is a 6-year maintenance term contract from 1 April 2018 to 31 March 2024. The works mainly comprise the management and maintenance of public roads including associated slopes, highway structures, tunnels, landscaping and minor improvement works in Kowloon East but excluding Expressways and High Speed Roads.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon on Friday, 1 December 2017. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 1 December 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Contractors on the List of Approved Contractors for Public Works in Group C (confirmed) for Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C (confirmed) for Roads and Drainage Category who also meet the qualifications and conditions for participation stipulated in the tender documents are invited to tender.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (confirmed) for Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category on or before 15 November 2017 to Chief Highway Engineer/Kowloon, Urban Region (Kowloon), Highways Department at 13th Floor, Nan Fung Commercial Centre, 19 Lam Lok Street, Kowloon Bay, Kowloon, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
