

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1067EM17T—Triennial Term Contract for Maintenance and Modification Works of Digital Red Light Camera System (Phase I and II) for Hong Kong Police Force**. The scope of the works includes comprehensive maintenance and repair of Digital Red Light Camera System (Phase I and II) of Hong Kong Police Force. The Contract is scheduled to commence in March 2018 for completion in February 2021.
