

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1410EM17T—Triennial Term Contract for Maintenance of Heating, Ventilation and Air-conditioning Installations for Customs and Excise Department, Fire Services Department and Immigration Department in Kowloon for the Government of the Hong Kong Special Administrative Region**. The scope of the works includes provision of maintenance services and carrying out of alteration, addition, replacement and improvement works of air-conditioning installations for venues of the Customs and Excise Department, Fire Services Department and Immigration Department in Kowloon Region. The works are scheduled to commence in March 2018 for completion in February 2021.
