

It is hereby notified that tenders are invited for **Contract No. 2418EM17T—Triennial Term Contract for Building Services Fitting-out, Replacement and Improvement Works for Health Sector Services in Kowloon East Region**. The scope of the works includes fitting-out, replacement of, alterations, additions and improvement to building services installations and associated builder's works for the health sector venues in the Kowloon East Region. The contract is scheduled to commence in February 2018 for completion in January 2021.
