

TOWN PLANNING ORDINANCE (Chapter 131)

AMENDMENTS TO THE APPROVED POK FU LAM  
OUTLINE ZONING PLAN NO. S/H10/15

In the exercise of the power conferred by section 12(1)(b)(ii) of the Town Planning Ordinance (the Ordinance), the Chief Executive in Council (CE in C) on 17 October 2006 referred the approved Pok Fu Lam Outline Zoning Plan No. S/H10/15 to the Town Planning Board (the Board) for amendment.

The Board has made amendments to the Plan. The amendments are set out in the Schedule of Amendments. The descriptions of the areas affected by the amendments in the Schedule of Amendments are for general reference only. The exact locations of the areas affected by the amendments are more specifically shown on the draft Pok Fu Lam Outline Zoning Plan No. S/H10/16.

The draft Pok Fu Lam Outline Zoning Plan No. S/H10/16 showing the amendments is exhibited under section 5 of the Ordinance for public inspection for a period of two months from 15 September 2017 to 15 November 2017 during normal office hours at the following locations:—

- (i) the Secretariat of the Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (ii) the Planning Enquiry Counter, 17th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (iii) the Planning Enquiry Counter, 14th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories;
- (iv) the Hong Kong District Planning Office, 14th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong; and
- (v) the Southern District Office, Public Enquiry Service Centre, Ground Floor, Ocean Court, 3 Aberdeen Praya Road, Aberdeen, Hong Kong.

In accordance with section 6(1) of the Ordinance, any person may make representation to the Board in respect of any of the amendment. The representation should be made in writing to the Secretary, Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong not later than 15 November 2017.

In accordance with section 6(2) of the Ordinance, a representation shall indicate:—

- (a) the particular matter in any of the amendment to which the representation relates;
- (b) the nature of and reasons for the representation; and
- (c) the amendments (if any) proposed to the draft plan.

Any representation made to the Board will be available for public inspection under section 6(4) of the Ordinance until the CE in C has made a decision in respect of the draft plan in question under section 9. Any person who intends to make representation is advised to read the 'Town Planning Board Guidelines on Submission and Publication of Representations, Comments on Representations and Further Representations under the Town Planning Ordinance' (the Guidelines) for details. Statement on Personal Data

The personal data submitted to the Board in any representation will be used by the Secretary of the Board and Government departments for the following purposes:—

- (a) the processing of the representation which includes making available the name of the person making the representation (hereafter known as 'representer') for public inspection when making available the representation for public inspection; and
- (b) facilitating communication between the 'representer' and the Secretary of the Board/Government departments in accordance with the provisions of the Ordinance and the relevant Town Planning Board Guidelines.

MADE BY THE TOWN PLANNING BOARD  
UNDER THE TOWN PLANNING ORDINANCE (CHAPTER 131)**

**I. *Amendments to Matters shown on the Plan***

- Item A — Rezoning of a site between Pok Fu Lam Road and Victoria Road from 'Open Space' ('O'), 'Government, Institution or Community' ('G/IC') and 'Green Belt' ('GB') to 'Residential (Group A)' ('R(A)').
- Item B — Rezoning of a site at Wah King Street from 'O' and an area shown as 'Road' to 'R(A)'.
- Item C — Rezoning of a site at Wah Lok Path from 'G/IC' to 'R(A)'.
- Item D — Incorporation of a piece of land to the east of Shek Pai Wan Road excised from the approved Aberdeen and Ap Lei Chau OZP No. S/H15/31 into the planning scheme area and rezoning it together with an adjoining site to its north from 'GB' to 'R(A)'.
- Item E — Rezoning of a site to the east of Pok Fu Lam Road from 'GB' and 'G/IC' to 'Residential (Group A) 1' ('R(A)1').

**II. *Amendment to the Notes of the Plan***

Revision to the Schedule of Uses of the Notes for the 'R(A)' zone to incorporate 'Public Vehicle Park (excluding container vehicle) (on land designated 'R(A)1' only' as a Column 1 use, and to correspondingly replace 'Public Vehicle Park (excluding container vehicle)' under Column 2 by 'Public Vehicle Park (excluding container vehicle) (not elsewhere specified)'.
