## PROPOSED ROAD WORKS FOR THE FUTURE WEST RAIL YUEN LONG STATION PROPERTY DEVELOPMENT

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing covered footbridge, carriageways, footpaths, cycle track and central medians/traffic islands within the limit of works area as shown on Plan No. YL-001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 6773 published on 28 November 2014 and 5 December 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 16 November 2017 to 15 November 2018, all public or private rights in, upon, under or over the sections of the existing covered footbridge, carriageways, footpaths, cycle track and central medians/traffic islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure is mainly to facilitate the future property development at the West Rail Yuen Long Station including modification of the existing covered footbridge and construction of the carriageways, footbridge, footpaths, emergency vehicular access, central medians/traffic islands, cycle track, public motorcycle parking spaces, public bicycle parking spaces and ancillary works including drainage works, pedestrian crossing facilities, associated utilities and reinstatement works.
