

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2682EM17T, Quadrennial Term Contract for the Comprehensive Maintenance and Repair of Escalator Installations at Various Premises of Hospital Authority (AE18)**. The scope of the Works includes maintenance and repair of escalator installations in various premises of the Hospital Authority. The Works are scheduled to commence in April 2018 for completion in March 2022.
