## TENDER FOR PROJECT BUILDING INFORMATION MODELLING (BIM) TERM SERVICES BATCH 2017

Tenders for NINE Service Agreements for providing BIM Services for 21 public housing projects and one central support service (2017 – 2019) are hereby invited. Tender documents are obtainable from the General Registry of Structural Engineering Section / Development and Construction, 8/F Block 2, Housing Authority Headquarters, 33 Fat Kwong Street, Kowloon.

The major scope of services includes but not limited to the following: -

- (a) Provision of BIM Modellers to be stationed at Housing Authority Headquarters to carry out the BIM services required by the Agreements;
- (b) Creation, development and/or modification of BIM models with respect to different building disciplines;
- (c) Provision of BIM services for the planning, design, submission, and tender stages of the projects named in the Agreements and/or other un-named projects that may be added in the course of the Agreements; and
- (d) Provision of BIM training that may be ordered in the course of the Agreements.

All service providers interested to tender MUST attend a <u>tender briefing session</u> to be convened <u>on 10 November 2017</u>. Only those service providers who have collected the tender invitation letter and the tender document will be informed about the time and venue of the tender briefing session.

Tenders must be clearly marked with tender reference and be submitted according to the envelope arrangement described in the tender invitation letter, and reached the Hong Kong Housing Authority before the time as specified in the tender document in one of the following ways:

Late tenders shall not be considered. The Hong Kong Housing Authority does not bind itself to accept the lowest or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.

The tenderers shall meet the following mandatory tender requirements: -

- The Company shall be set up in Hong Kong with at least ONE year of Company and Business Registration in the Companies Registry of Hong Kong SAR at the time of submission of tender;
- (ii) The Company shall have at least ONE staff being a professional member of the Hong Kong Institute of Building Information Modelling (HKIBIM); and
- (iii) Upon request, the tenderers shall assist the Tender Evaluation Team (TET) to conduct visit(s) to their local office during the tender evaluation period.
