It is intended to invite tenders in March 2018 from prequalified tenderers for Contract No. 13/WSD/17 'Design, Build and Operate First Stage of Tseung Kwan O Desalination Plant'. The scope of works of the contract comprises the design, construction, operation and maintenance of the first stage of Tseung Kwan O (TKO) Desalination Plant which is located at TKO Area 137 to produce potable water by seawater reverse osmosis technology at a water production capacity of 135 000 cubic metres per day (m³/day). The first stage of TKO Desalination Plant will have provision for future expansion to the ultimate water production capacity up to 270 000 m³/day, including civil engineering and building works for the common facilities, such as the seawater intake and outfall facilities, administration building, electricity transformer station and chemical building, which are used by both the first and ultimate stages. The operation period of the first stage of TKO Desalination Plant will be 10 years (starting from commissioning of the first stage of TKO Desalination Plant) plus an optional extension of 5 years at the discretion of the Government of the Hong Kong Special Administrative Region.

All applicants should read the Instructions to Applicants and the Prequalification Document and note in particular paragraphs 2 and 37 of the Instructions to Applicants. Applicants who are able to demonstrate that they have sufficient technical strength and experience in design, construction, operation and maintenance of seawater desalination plants adopting reverse osmosis technology and with sound financial resources and meeting other qualifications and conditions for participation stipulated in the prequalification documents are invited to apply for prequalification.

Late applications will not be accepted.

If a black rainstorm warning signal or tropical cyclone signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on 22 December 2017, the closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone signal No. 8 is lowered.

Joint ventures satisfying the requirements stated in the prequalification documents will be considered.
