

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2109EM17T, Triennial Term Contract For Building Services Fitting-Out Works, Replacement And Improvement Works To Health Sector Venues In New Territories West Region**. The scope of the works includes building services fitting-out works, replacement, addition, alteration and improvement works in hospitals, clinics and venues operated by Hospital Authority and Department of Health in New Territories West Region. The works are scheduled to commence in February 2018 for completion in January 2021.
