TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing footbridge, footpath and carriageway within the limit of works area as shown on Plan No. HWDSK055D-GZ0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 2407 published on 24 April 2009 and 30 April 2009. The Acting Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 31 December 2017 to 30 December 2018, all public or private rights in, upon, under or over the sections of the existing footbridge, footpath and carriageway to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of an elevated walkway between Tong Ming Street and Tong Tak Street, provision of two lifts, demolition of an existing footbridge ramp, reconstruction of the existing cycle parking area and other ancillary works.
