PROPOSED PERMANENT CLOSURE OF A SECTION OF ON MUK STREET AND ASSOCIATED WORKS

TAKE NOTICE that under powers delegated by the Chief Executive, the Acting Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, cycle tracks and central medians/traffic islands within the limit of works area as shown on Plan No. ST51/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 1634 published on 13 February 2015 and 18 February 2015. The Acting Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 30 December 2017 to 29 December 2018, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, cycle tracks and central medians/traffic islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a roundabout at the truncated end of On Muk Street, conversion of an existing signalised junction to a roundabout at the junction of On Ming Street/On Yiu Street/On Muk Street and ancillary works including civil engineering, drainage, sewerage and water works.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted via one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
