

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. GE/2018/03, Landslip Prevention and Mitigation Programme, 2012, Package C, Landslip Prevention and Mitigation Works in Lantau and Hong Kong Island**. The works include upgrading of 10 government slopes and retaining walls and natural terrain mitigation works to 24 natural hillside catchments in Lantau Island and Hong Kong Island. The works are scheduled to commence in March 2018 and will take about 30 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon on Friday, 26 January 2018. Late tenders will not be accepted.

If a black rainstorm warning signal or a tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 26 January 2018, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works—Landslip Preventive/Remedial Works to Slopes/Retaining Walls may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 9 January 2018 to Chief Geotechnical Engineer/LPM 2, LPM Division 2, Geotechnical Engineering Office, Civil Engineering and Development Department at 10th Floor, Civil Engineering and Development Building, 101 Princess Margaret Road, Ho Man Tin, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
