

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2849EM17A—District Cooling System (DCS) at Kai Tak Development (KTD) Phase III (Package D)—Water Pipe Laying Works in North Apron**. The scope of the works includes laying of DCS chilled water pipes at Kai Tak Development. The works are scheduled to commence in July 2018 for completion in June 2020.
