ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

PWP ITEM NO. 7279RS—CYCLE TRACKS CONNECTING NORTH WEST NEW TERRITORIES WITH NORTH EAST NEW TERRITORIES—TUEN MUN TO SHEUNG SHUI SECTION (STAGE 1)

(FORMERLY KNOWN AS 'PWP ITEM NO. 7259RS (PART)—
CYCLE TRACKS CONNECTING NORTH WEST NEW TERRITORIES WITH
NORTH EAST NEW TERRITORIES—SECTION FROM TUEN MUN TO
SHEUNG SHUI')

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing roads, footpaths/staircases, cycle tracks and tracks within the limit of works area as shown on Plans Nos. NTN2214 (except limit of works area of the proposed cycle track shown on the Plan), NTN2217 (except limit of works area of the proposed cycle track shown on the Plan), NTN2218 (except limit of works area of part of the proposed cycle track shown on the Plan), NTN2219 (except limit of works area from chainage CH-MP0+000m to CH-MP1+000m and from chainage CH-MP1+110m to CH-MP1+800m shown on the Plan) and NTN2226 (except limit of works area from chainage CH-KW3+645m to CH-KW3+950m shown on the Plan) ('the Plans') and described in the scheme annexed thereto, and as modified by Modification Plan No. NTN2217A ('the Modification Plan'), and as amended by Second Amendment Plan No. NTN2226A ('the Second Amendment Plan') and described in the second amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 3720 published on 6 June 2008 and 13 June 2008. The Modification Plan was referred to in G.N. 211 published on 15 January 2010 and 22 January 2010. The Second Amendment Plan and second amendment scheme were referred to in G.N. 5492 published on 26 September 2014 and 3 October 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 30 December 2017 to 29 December 2018, all public or private rights in, upon, under or over the sections of the existing roads, footpaths/staircases, cycle tracks and tracks to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of facilities associated with the cycle tracks along Kam Tin River, Sheung Yue River and Shek Sheung River; construction of entry/exit hubs; and ancillary works including water, drainage, sewerage, geotechnical and landscaping works, construction of retaining structures and installation of traffic aids.

A copy of the order, the Plans, the Modification Plan and the Second Amendment Plan may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected roads, footpaths/staircases, cycle tracks and tracks on 22 December 2017.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—

- (1) By post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8.00 a.m. and 7.00 p.m. from Monday to Friday (except public holidays);

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims served under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is obligatory. If such information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
