

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1558EM17T, Triennial Term Contract for the Operation and Maintenance of Air-conditioning Installations at Unattended Municipal Venues in Hong Kong Region**. The scope of the works includes operation and maintenance of air-conditioning installations for unattended municipal venues in Hong Kong Region.
