

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. HY/2014/10, Tuen Mun—Chek Lap Kok Link—Northern Connection Traffic Control and Surveillance System (Public Works Programme Item No. 857TH)**. The works mainly comprise design, supply, delivery, installation, testing and commissioning of a traffic control and surveillance system that covers mainly the roads at Tuen Mun—Chek Lap Kok Link Northern Connection. The system will mainly consist of computer systems, communication facilities, variable message signs and other traffic field equipment.

The works are scheduled to commence in May 2018 and will take about 29 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Logistics Department Tender Box situated on the Ground Floor of North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 9 February 2018. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 9 February 2018, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Open tendering is adopted. All interested contractors who also meet the following requirement are invited to tender:—

- (a) having completed at least one construction contract of Traffic Control and Surveillance System at roads, with an adjusted contract sum of not less than HK\$25 million, in or outside Hong Kong, within the past 15 years, counting from the original date set for the close of tender. The adjusted contract sum shall be the awarded contract sum adjusted to current price level as stipulated in the tender documents; and
- (b) in the case of a joint venture tenderer, the lead participant or the major shareholder in the joint venture meets the requirement (a) above.

The detailed requirements on the tenderer's qualification and those for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender with the highest overall score.

The Government of the Hong Kong Special Administrative Region reserves the right to negotiate with any tenderer about the terms of the offer.
