

It is hereby notified that tenders are invited for the **Contract No.: 2656EM17T, Triennial Contract for the Operation and Maintenance of Electrical, Mechanical and Other Installations for Municipal Venues in Kowloon of the Government of the Hong Kong Special Administrative Region (Package II)**. The scope of the works of the Contract includes operation and maintenance of electrical, mechanical and other installations for municipal venues of the Government of the Hong Kong Special Administrative Region in Kowloon Region. The Contract is scheduled to commence in August 2018 for expiration in July 2021.
