3. Only eligible companies in the List above will be considered for invitation to tender based on their proven capability and performance.
4. Inclusion on the above List in any particular Category or Group does not give companies the right to tender for any contract in that or any other Category or Group. The number of companies invited to submit tenders for each individual contract may be limited, with the list of companies invited to tender on each occasion being at the sole discretion of HA. Selected companies will then be formally invited separately to tender for each contract.
5. Conditions of tenders and tender documents can be collected by selected companies at the address as shown in the 'Letter of Invitation to Tender'.
6. The contract(s) will be awarded by the Hong Kong Housing Authority.
7. Once companies have notified HA of their intention to tender and have been invited, they are obliged to submit a tender in compliance with tender conditions and in accordance with the timeframe as described in the 'Letter of Invitation to Tender' which they will receive at a later stage. Failure to respond to the invitation, to collect the tender documents and / or to submit a tender in compliance with tender conditions will be considered as a tendering irregularity and the companies concerned may be subject to appropriate regulatory actions.
8. For those who are not on the above List but interested in undertaking the Contract(s), they are required to apply to the Gas Authority, the Government of the Hong Kong Special Administrative Region for consideration for admission on the List.
9. This notification includes contract(s) covered by the Agreement on Government Procurement of the World Trade Organization. This notification also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.
10. Details of the award of the contract(s) will be published in the Government of the Hong Kong Special Administrative Region Gazette.
