PROPOSED ROAD WORKS AT CLEAR WATER BAY ROAD, SAI KUNG AND PROPOSED TA KU LING RESIDENTIAL SITE

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. SKM9763 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:----

- (i) construction of a retaining wall and a slope;
- (ii) permanent closure and conversion of a section of the existing footpath into carriageway and refuge island;
- (iii) permanent closure and conversion of a section of the existing amenity area into carriageway;
- (iv) permanent closure of an existing staircase, and a section of the existing carriageway and footpath;
- (v) temporary closure and reconstruction of sections of the existing footpath;
- (vi) demolition and conversion of a section of the existing slope into carriageway, footpaths and refuge island; and
- (vii) ancillary works including drainage, water, utilities, street lighting and landscaping works.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 7th day of February 2023.
