#### NOTICE OF TRANSFER OF BUSINESS

Pursuant to Sections 4 and 5 of the Transfer of Business (Protection of Creditors) Ordinance (Chapter 49 of The Laws of Hong Kong)

NOTICE is hereby given that BONNIE INTERNATIONAL (HONG KONG) LIMITED, a company incorporated in Hong Kong, whose registered office is at 5/F, Manulife Place, 348 Kwun Tong Road, Kowloon, Hong Kong (the “Transferor”).

The Transferor agreed to transfer to Jipei Green Science and Technology (Dongguan) co., Ltd, a company incorporated in People’s Republic of China, whose registered office is at Room 501, 96 Lianfeng New Road, Dalingshan, Dalingshan Town, Dongguan, Guangdong, People’s Republic of China (the “Transferee”) its business (the “Business”) of design, procurement, manufacture, marketing and sale of cosmetic bags and related products and secondary packaging (rigid boxes, folding cartons, platforms, tins, glass, plastics, et al) (which have been principally been carried out under the name of Bonnie International (HK) Limited) and certain assets thereof in relation to the Business.

The Transferee shall not assume any of the debts, liabilities and obligations arising out of the Business by the Transferor prior to the Transfer Date.
