

MEDICAL REGISTRATION ORDINANCE (Chapter 161)

ORDER MADE BY THE MEDICAL COUNCIL OF HONG KONG

It is hereby notified that the Medical Council of Hong Kong after due inquiry held on 18 September 2006 in accordance with section 21 of the Medical Registration Ordinance, Chapter 161 of the Laws of Hong Kong, was satisfied that Dr. LI Sai Lai Ronald, being a registered medical practitioner, was convicted at the Kowloon City Magistrates' Courts on 27 October 2005 of three offences punishable with imprisonment, namely:—

- (1) failing to keep a register of dangerous drugs in the form specified in the First Schedule to the Dangerous Drugs Regulations (Chapter 134A), contrary to regulations 5(1)(a) and 5(7) of the Dangerous Drugs Regulations;
- (2) failing to use a separate page within the register or separate parts of the register for the entries of different dangerous drugs, contrary to regulation 51(1)(c) of the Dangerous Drugs Regulations; and
- (3) failing to keep a register or records of dangerous drugs, contrary to regulations 5(1)(a) and 5(7) of the Dangerous Drugs Regulations.

The Council was satisfied that Dr. LI Sai Lai Ronald has been guilty of the above charges.

In accordance with section 21(1)(iv) of the Medical Registration Ordinance, the Medical Council ordered on 18 September 2006 that the name of Dr. LI Sai Lai Ronald be removed from the General Register for a period of one month, and the order be suspended for a period of one year, subject to the condition that during the suspension period his practice shall be subject to satisfactory peer audits and supervision in accordance with the following terms:—

- (a) A registered medical practitioner of good standing shall be nominated for the Council's approval to conduct the audits and supervision.
- (b) The supervising doctor shall attend his clinic without prior notice to conduct on-site audits and supervision. Such audits and supervision shall take place not less than once every three months.
- (c) The supervising doctor shall inspect and conduct random checks on the relevant records (including but not limited to medical records of the patients, inventory and records of medicines, records and registers of dangerous drugs) as he considers necessary to ensure that the provisions of the Dangerous Drugs Regulations are complied with.
- (d) The supervising doctor will supervise the Defendant's consultation of patients at his discretion.
- (e) The supervising doctor shall have access to the dispensary and other areas of the clinic to ensure that the safe custody of dangerous drugs complies with the provisions of the Dangerous Drugs Regulations.
- (f) The supervising doctor shall report directly to the Medical Council the results of the audits and supervision every three months and, if any defect is detected, such defect should be reported as soon as practicable.

In accordance with section 21(5) of the Medical Registration Ordinance, the above order shall be published in The Government of the Hong Kong Special Administrative Region Gazette.
