IMPROVEMENT OF ACCESS ROAD AT MOK TSE CHE, SAI KUNG

TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 13(1) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (hereinafter referred to as 'the Ordinance') directing that all those pieces or parcels of land in Sai Kung, New Territories known and registered in the Land Registry as:—

Lots Nos. 15 (Portion), 16 S.A ss.2 (Portion), 16 S.A RP (Portion), 16 S.B, 17 (Portion), 37 S.A (Portion), 38 RP (Portion) and 39 (Portion) all in Demarcation District No. 223

as shown coloured orange stippled black on the Resumption Plan No. SKM5046k annexed to the said order, which land was described in the scheme referred to in Government Notice No. 7306 published on 27 November 2009 and 4 December 2009 with amendments as described in Government Notice No. 5263 published on 20 August 2010 and 27 August 2010 and with second amendments as described in Government Notice No. 4849 published on 20 July 2012 and 27 July 2012, shall be resumed.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing before the expiration of one year from the date of resumption.
