TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 13(1) of the Roads (Works, Use and Compensation) Ordinance (hereinafter referred to as 'the Ordinance') as applied by section 26 of the Water Pollution Control (Sewerage) Regulation directing that all those pieces or parcels of land in Tai Po, New Territories known and registered in the Land Registry as:—

as shown coloured orange stippled black on the Resumption Plan No. TPM5561a annexed to the said order, which land was described in the scheme referred to in Government Notice No. 6733 published on 18 October 2007 and 26 October 2007 with amendments as described in Government Notice No. 2469 published on 18 April 2008 and 25 April 2008, shall be resumed.

Any person entitled to compensation under Part V of the Water Pollution Control (Sewerage) Regulation may serve a written claim upon the Secretary for the Environment before the expiration of one year from the date of resumption.
