

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. GE/2012/07, Landslip Prevention and Mitigation Programme, 2008, Package A, Landslip Prevention and Mitigation Works at Repulse Bay Road and South Bay Road**. The works include upgrading of 3 government slopes and retaining walls and natural terrain mitigation works to 7 natural hillside catchments at Repulse Bay Road and South Bay Road. The works are scheduled to commence in January 2014 and will take about 30 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 15 November 2013. Late tenders will not be accepted.

In the event a tropical cyclone warning signal No. 8 or above or a black rainstorm warning signal is in force between 9.00 a.m. and 12.00 noon on Friday, 15 November 2013, the tender closing time will be postponed to 12.00 noon on the first working day of the following week. An announcement of the change will be made through the radio.

Contractors will be liable to have their names removed from the approved list if they fail or refuse to implement an accepted tender.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for the delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
