TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, the Deputy Director/Specialist, Lands Department has made an order under section 13(1) of the Roads (Works, Use and Compensation) Ordinance (hereinafter referred to as 'the Ordinance') as applied by section 26 of the Water Pollution Control (Sewerage) Regulation directing that all those pieces or parcels of land in Tai Po, New Territories known and registered in the Land Registry as:—

(Portion), 466 RP (Portion), 467 (Portion), 468 RP (Portion), 469 S.A (Portion), 472 (Portion), 473 (Portion), 474 (Portion), 475 S.A (Portion), 475 RP (Portion), 518 RP (Portion), 521 S.A (Portion), 521 RP, 757 S.B ss.26 S.A (Portion), 757 S.B ss.26 RP (Portion), 757 S.B ss.28 (Portion), 769 S.B RP (Portion) and 769 S.C RP (Portion) all in Demarcation District No. 28

as shown coloured orange stippled black on the Resumption Plan No. TPM5658a annexed to the said order, which land was described in the scheme referred to in Government Notice No. 3969 published on 12 July 2013 and 19 July 2013 as rectified by Corrigendum in Government Notice No. 6390 published on 25 October 2013 and 1 November 2013, shall be resumed.

Administrative Region for the purposes of or incidental to the works or use described in the said scheme.

Any person entitled to compensation under Part V of the Water Pollution Control (Sewerage) Regulation may serve a written claim upon the Secretary for the Environment before the expiration of one year from the date of resumption.
