

## RAILWAYS ORDINANCE (Chapter 519)

(Notice under section 21)

MASS TRANSIT RAILWAY ('MTR')  
WEST ISLAND LINEAMENDMENT TO CREATION OF RIGHTS OF  
TEMPORARY OCCUPATION OF LAND

TAKE NOTICE that under powers delegated by the Chief Executive, the Deputy Director/Specialist, Lands Department has made an order under section 20(1) of the Railways Ordinance (Chapter 519) (hereinafter referred to as 'the Ordinance') and section 46 of the Interpretation and General Clauses Ordinance (Chapter 1) directing that the rights of temporary occupation of land created by the order referred to in Government Notice No. 7751 dated 11 December 2009 (hereinafter referred to as 'the Original Order') be amended to the effect that in relation to the land more particularly described in the first column below as shown coloured purple stippled black on Creation of Rights of Temporary Occupation of Land Plan No. RDM1011 annexed to the Original Order which land was described in the scheme referred to in Government Notice No. 6865 published on 26 October 2007 and 2 November 2007, and as amended by Government Notice No. 6294 published on 12 September 2008 and 19 September 2008, and as corrected by Government Notice No. 135 published on 9 January 2009 and 16 January 2009, and as modified by Government Notice No. 1835 published on 20 March 2009 and 27 March 2009, and was authorized by the Chief Executive in Council and such authorization was gazetted in Government Notice No. 1835 published on 20 March 2009 and 27 March 2009, the period during which rights of temporary occupation of land have been created shall be amended as described in the second column below:—

*Description of Land*

Portion of the Remaining Portion of Section A of Inland Lot No. 834

(Between the level of 23.0 metres above Principal Datum of Hong Kong (which expression shall have the same meaning as in the First Schedule to the Interpretation and General Clauses Ordinance (Chapter 1) and is hereinafter referred to as 'P.D.') and the level of 5.2 metres above P.D.)

Portion of the Remaining Portion of Subsection 1 of Section B of Inland Lot No. 834

(Between the level of 23.0 metres above P.D. and the level of 5.2 metres above P.D.)

Portion of the Remaining Portion of Inland Lot No. 2484

(Between the level of 23.0 metres above P.D. and the level of 2.0 metres above P.D.)

*Amended Period during which Rights of Temporary Occupation of Land are to be Created*

From 12 March 2010 to 31 March 2015 instead of from 12 March 2010 to 31 August 2014

From 12 March 2010 to 31 March 2015 instead of from 12 March 2010 to 31 August 2014

From 12 March 2010 to 31 March 2015 instead of from 12 March 2010 to 31 August 2014
